**What you need to bring:** • Valid photo ID. • Original Social Security Cards for all household members. • Identity Theft prevention pin, if assigned. • A copy of last year's tax return, if available. • Health Insurance (Form 1095-A) • Income documents such as Forms W-2, W-2G, & 1099S • Interest and dividend statements from banks (Forms 1099). • Bank Routing Numbers and Account Numbers for Direct Deposit of refund. • For students with post-secondary tuition expenses or grant income bring Form 1098-T • Total paid for day care provider and the day care provider's tax identifying number. • Both spouses must be present to sign the required forms for Married Filing Jointly returns. • VITA sites do **not** prepare Married Filing Separately returns • High School sites do not prepare self-employment returns (Schedule C)
